

**Terms of Use for SILE Websites**

NOTE: 'You' and 'Your' refers to an individual using the SILE Websites (and includes the organization he or she is acting on behalf of where such use is on behalf of the organization).

**1. General**

Please review these Terms periodically as Your continued use of the SILE Websites is deemed acceptance of any revised Terms in force at the time.

**2. Permitted usage**
