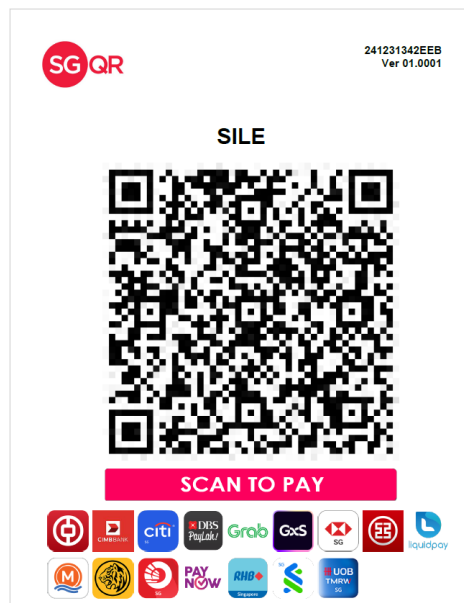


## REGISTRATION FOR 2026 PART B BAR COURSE & EXAMINATIONS SESSION 1 [RETAKERS FROM PREVIOUS SESSIONS]

1. Candidates who failed their Part B Bar Examinations in the previous attempt(s) may register to retake their failed subject(s) at Session 1 of Part B Bar Examinations 2026. Candidates retaking the Part B Bar Examinations **MUST** register and pay for **ALL** their failed subjects. To register, you must complete the registration form on page 3.
2. **The fee for retaking 1 module is \$545.00 (inclusive of GST).**
3. **Modes of Payment**

Candidates may now select the following modes of payment for the fee:

**Important: For all mode of payments, candidates must indicate "B - [candidate's full name]" in the payment details. Include as much of your full name as the space will allow.**

4. Please email the completed registration form (i.e., page 3) and screenshot of your payment details to [partb.application@sile.edu.sg](mailto:partb.application@sile.edu.sg). The screenshot of your transmission receipt/ payment details must include (i) the full name stated in the bank transfer; (ii) the date of transfer; and (iii) the amount transferred. Both the form and fees must reach us **by 5pm on Friday, 26 September 2025.**

### SkillsFuture Credits (SFC)

1. All Singapore citizens aged 25 and above will be able to utilise their SFC account to pay for the Part B Course fee.
2. If you would like to utilise your SFC, do take note of the following:
  - (a) Only **Base-Tier SFC** may be used for offsetting the Part B Course fee (Mid-Career Tier SFC are **NOT** eligible for claims).
  - (b) Please make payment of the Part B Course fee **less** the SFC amount you will be claiming. **If this figure is incorrect, the SFC authority will reject the request to utilise the SFC.**
  - (c) A screenshot of your **Base-Tier SFC** balance must be attached at the point of application submission.
  - (d) Please submit an SFC claim by logging in to <https://www.myskillsfuture.gov.sg/> **only after you have received an invoice from SILE.**
  - (e) Please note that the SFC claim window will be open from **16 November 2025 to 14 January 2026**. Do note that late submissions will not be accepted.
3. Please also note the following before deciding to utilise your SFC:
  - (a) If you have already made an initial self-payment for the Part B Course in full, you will not be able to use SFC for this course.
  - (b) SFC is not intended to pay for training provided by employers, which should continue to be borne by your employer. If you need further clarification, please write to <https://service-portal.skillsfuture.gov.sg>.

### Post-Secondary Education Account (PSEA)

4. Singapore citizens who wish to use the fund from their PSEA to reimburse their Course and Examinations fees may do so from **23 February 2026 to 6 March 2026**. More details pertaining to the application process will be announced on SILE Campus closer to the application date.
