

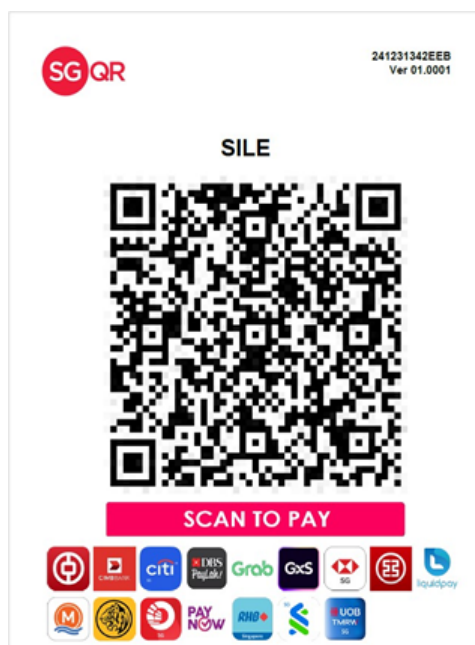
REGISTRATION FOR 2026 PART A BAR COURSE & EXAMINATIONS SESSION 1 [RETAKERS FROM PREVIOUS SESSIONS]

- Candidates who failed their Part A Bar Examinations in the previous attempt(s) may register to retake their failed subject(s) at Session 1 of Part A Bar Examinations 2026. Candidates retaking the Part A Bar Examinations **MUST** register and pay for **ALL** their failed subjects. To register, you must complete the registration form on page 7.

4. **Indicate “A-[FULL NAME OF APPLICANT]” in the payment details. Include as much of your full name as the space will allow. This will allow us to verify that payment has been made. The payment screenshot must show the applicant’s full name and that the transfer has been made. If we are not able to confirm your payment, you may be asked to submit additional documentary proof.**
5. You are responsible for any bank charges that may be imposed and must ensure that we receive the full amount clear of any bank charges. Paying us the wrong amount or failing to indicate your full name may cause a delay in processing. We will not process your payment unless full payment is received. If you make excess payment, you may be liable for bank / administrative charges for processing a refund.

SkillsFuture Credits (SFC)

6. All Singapore citizens aged 25 and above will be able to utilise their SFC account to pay for the optional Course fee.
7. If you would like to utilise your SFC, do take note of the following:
 - (a) Only **Base-Tier SFC** may be used for offsetting the optional Course fee (Mid-Career Tier SFC are **NOT** eligible for claims).
 - (b) Please make payment of the optional Course fee **less** the SFC amount you will be claiming. **If this figure is incorrect, the SFC authority will reject the request to utilise the SFC.**
 - (c) A screenshot of your **Base-Tier SFC** balance must be attached at the point of application submission.
 - (d) Please submit an SFC claim by logging in to <https://www.myskillsfuture.gov.sg/> **only after you have received an invoice from SILE.**
 - (e) Please note that the SFC claim window will be open from **21 November 2025 to 19 January 2026**. Do note that late submissions will not be accepted.
8. Please also note the following before deciding to utilise your SFC:
 - (a) If you have already made an initial self-payment for the optional Course in full, you will not be able to use SFC for this course.
 - (b) SFC is not intended to pay for training provided by employers, which should continue to be borne by your employer. If you need further clarification, please write to <https://service-portal.skillsfuture.gov.sg>.

Post-Secondary Education Account (PSEA)

9. Singapore citizens who wish to use the fund from their PSEA to reimburse their optional Course and Examinations fees may do so from **2 February 2026 to 13 February 2026**. More details pertaining to the application process will be announced on SILE Campus closer to the application date.

2026 SESSION 1 PART A BAR COURSE - REGISTRATION GUIDE

SILE will accept registrations for the 2026 Session 1 Part A Bar Course from now until **5pm on Friday, 26 September 2025**.

- A. Read this Registration Guide carefully.
- B. Fill in the Registration Form found on page 7 of this Guide.
- C. Submit the Registration Form along with a screenshot of your payment via email to parta2026s1@sile.edu.sg **by 5pm on Friday, 26 September 2025**.
- D. SILE will notify you of the registration outcome by 12 December 2025.

Information on the Course Schedule

- 1. The Part A Bar Course is an optional course to prepare applicants for the Part A Bar Examinations. The course will tentatively take place from **19 January 2026 to 18 March 2026**.
- 2. There are currently 2 Seminar Groups (“SG”) planned for the 2026 Session 1 Part A Bar Course. The indicative course schedules for the 2 SGs will be shared closer to the course dates.
- 3. There are 5 webinars for each of the 5 examinable subjects. In total, there will be 25 webinars for each SG all of which will be conducted using Zoom Platform. To participate in the Webinar, you must have a computer compatible with Zoom, with a working web camera, microphone and speakers. Your camera **must be switched on** during the entire duration of the Webinar. **Do not register for the Course if you do not wish to attend webinars.**
- 4. The duration of each seminar is 90 minutes.
- 5. You will only attend the seminars for the SG which you have been assigned.

Selection and Allocation of Seminar Groups (“SG”)

- 6. Once the schedule has been finalised, we will send out the seminar group selection form to you via email.
- 7. SILE will endeavour to assign you an SG having regard to your preference indicated on the form. If a particular SG is over-subscribed, the allocation of candidates for that SG will be done by balloting.
- 8. You are strongly encouraged to indicate your choice(s) of SGs. (There is no guarantee that you will be assigned to the SGs of your choice, especially if it is the more popular SG.) If you can only attend one of the SGs, leave the 2nd Choice blank. If you only indicate 1 choice, and you are balloted out of it, you will not be assigned any SG. Your registration will be unsuccessful, and any course fee paid will be returned to you.
- 9. Once you have been assigned an SG which is one of your indicated choices, the allocation is final and the course fee paid is non-refundable. You are not allowed to switch SGs or attend the seminars of the other SGs.

10. The final course schedule stating the exact timings, will be provided to course candidates 2 weeks before the commencement of the Course. Login details to the webinars will be released through SILE Campus Calendar. You should expect to receive login details to SILE Campus by **5 January 2026**. Please note that the course schedule is subject to change depending on the facilitator's availability. Any changes to the schedule will be promptly announced on SILE Campus.
11. SILE reserves the right to discontinue any SG which is under-subscribed.

Important Notes and Rules

General

12. Candidates who did not register for the Course must not attend the webinars.
13. The Part A Bar Course is optional. If you are unable to plan your work; relevant legal training ("RLT"), relevant legal practice ("RLP") or relevant legal work ("RLW") schedule to attend the Course, please do not register for it.
14. There may be other changes to the course schedule which may arise due to the facilitators' work requirements. These changes will be brought to the affected candidates' attention (such as through a notice in the learning management system, SILE Campus) as soon as practicable.

Attendance

15. You can only attend the webinars for your assigned SG. You are not allowed to swap webinars with another candidate or attend the webinars of another SG.
16. There are no make-up webinars if you are unable to attend due to work, RLT, RLP, RLW or other personal commitments.
17. If you are unwell and cannot attend a webinar, you must send SILE a valid medical certificate by the following business day. SILE may, but is not obliged to, arrange for you to attend a make-up webinar with another SG, subject to availability. It is in SILE's absolute discretion whether to make such an arrangement, and not an entitlement of the course candidates.
18. **You MUST NOT under any circumstances attend the webinar of any other SG without SILE's prior written consent.**

Webinars

19. When attending a webinar on Zoom, your profile name must reflect your full name as per your NRIC, you must turn on the camera in Zoom and the camera is to be kept on for the entire Webinar. Ensure that the computer that you use to access the webinar has a built-in webcam or external camera attached to it. If you do not comply with the requirements, the facilitator and/or SILE staff will remove you from the webinar.
20. You must not share the login details to the webinars and invite other candidates to attend the webinars with you.

21. Recording and/or distributing any recorded webinars are strictly not allowed. Recording of the webinars is, amongst other things, an invasion of privacy for the instructors and other course candidates, and a violation of the intellectual property rights of the Institute.

Withdrawal policy

22. Payment of the Course fees is non-refundable, unless SILE, at its absolute discretion, determines otherwise. SILE will only consider withdrawal requests submitted on or before **27 February 2026** for refund purposes. The withdrawal fee may, at SILE's discretion, be deducted from any refund of fees paid to SILE.
23. If you wish to withdraw from the Part A Exams, you must first write in to SILE as follows:

24. If you withdraw your candidature after SILE has conditionally accepted your application, on or before 12 December 2025, or if your candidature is deemed to be withdrawn, you will be eligible for a refund less the **withdrawal fee**, i.e., S\$545 (inclusive of GST).
25. Any refund granted shall be in SILE's sole discretion. No refund will be given if you withdraw your candidature **after 27 February 2026**.

Request for special arrangements

26. If you require any special arrangement during the Part A Examinations due to existing medical and/or other conditions, you must make a formal request by writing in to SILE **by 27 February 2026** as follows:

27. The request must:
- (a) State clearly the medical condition and the accommodations required during the examinations, e.g., how much extra time needed;
 - (b) Be supported by recent and relevant certification by a **Singapore registered medical specialist** who is recognised by the Singapore Medical Council. The certification should be made within 6 months before the commencement of the Examinations; and
 - (c) Include details, as well as supporting documents, of previous accommodation(s) given to you by an institution of higher learning or other examination board.
28. A certification may be rejected if it is deemed irrelevant, inadequate or not recognised. SILE may require you to attend a medical review by a medical specialist appointed by SILE. You will have to bear the costs of such a medical review, and consent to SILE receiving a medical report from the medical specialist on your condition. In granting you accommodations, SILE may impose any conditions as it deems appropriate, and you may be required to bear the costs of any special arrangements extended to you.

29. Disciplinary action will be taken against candidates found violating any of the rules in this Guide. Candidates found in breach of any rule may be barred from sitting for the Examinations.
30. SILE reserves the right to amend the rules or impose additional rules for the conduct of the Course.
