## About the Bursary

The Singapore Institute of Legal Education (SILE)'s Part B Donated Bursaries Fund is established from the generous donations from members of the legal fraternity, who wish to assist financially disadvantaged candidates for the Singapore Bar with their Part B Course and Examinations Fees.

SILE administers the bursary. The quantum disbursed per year is at SILE's sole discretion, depending on the financial needs of the applicant and whether the requisite eligibility criteria is met. # Terms and Conditions

## Eligibility

Please note that to apply and qualify for the bursary, the following conditions must be met:

1. Candidates should have successfully passed Part A by their second attempt (if applicable), and must be registered for the Part B Course and Examinations.
2. Candidates must not have previously attempted the Part B Examinations.
3. Candidates must be Singapore citizens or Singapore permanent residents.
4. Candidates should have a gross monthly household per capita income (PCI) of less than SGD \$2,700.\* Alternatively, candidates who can demonstrate a comparable level of financial need will also be considered.
5. Candidates must not require any exemption from the requirements to be recognised as a qualified person.

*\*Per Capita Income (PCI) is calculated by dividing the total gross income of all household members by the number of individuals in the household*

## Application

Candidates applying for the bursary must submit the following documents and information to SILE:

1. A copy of the candidate's NRIC;
2. A copy of the candidate's degree certificate and academic transcript;
3. A personal statement explaining why the candidate has chosen to pursue a career in law, outlining their professional goals and aspirations;
4. A statement detailing why financial assistance is required and proof of gross monthly household per capita income;
5. Part A Examinations results (if applicable); and
6. Any facts that may affect the candidate's suitability to practise as a Lawyer (Non-Practitioner) or as an Advocate and Solicitor in Singapore, or as a legal practitioner (by whatever name called) in any other jurisdiction.
